

## Due Diligence Report: ENVV Enters Asian Energy Drink Market: Jumps 33%

### Summary:

It also intends to develop its business to cater to seniors who can no longer manage independently, or who are isolated and lonely.

The Company intends to provide seniors with a program to socialize with others while still receiving needed care services. It also intends to provide seniors with a non-residential facility that supports the health, nutritional, social support and daily living needs. It intends to offer consumer range of options and choices for service, as well as counseling.

The Company intends to offer nursing services for medication administration and/or oversight; weight and vitals, and diabetic care, feeding tubes, dressing changes. It also intends to offer a range of activities, such as pet therapy, trivia, outdoor picnics, computers for memory enhancement or keeping in touch with grandchildren on social networks, dancing, arts and crafts and bingo, among others. The Company also intends to offer a Unisex Beauty Salon, with a range of salon and spa services, including haircuts and styling, perms, hair coloring, facials, manicure, pedicures and massages. It also intends to provide door to door transportation from its center in the morning and evening. As of April 30, 2015, the Company had no operations, and it had not generated any revenues.
